

Voluntary Interdistrict Choice Corporation Board Meeting Highlights • October 17, 2025

In actions at their October 17 meeting, the Board of Directors of the Voluntary Interdistrict Choice Corporation

- William Douthit provided the Board with a quote from Dr. Martin Luther King, "The Purpose of Education".
- •Madeleine Smith and Kuma Okoro, PhD students from Michigan State University, presented their research findings regarding the long-term effects of participation in the VICC program for students from St. Louis.
 - •Approved minutes of the June 10, 2025 VICC Board regular meeting.
- Approved all preliminary 2025/26 routes for transporting students to and from school. VICC expects to transport about 1,684 students using 79 buses, 30 vans, and 62.5 taxis. This represents a decrease in bus routes offset by an increase in van and taxi routes from 2024/25 due to the combined effect of decreased overall enrollment, combining certain elementary routes, placing students in higher capacity taxis and a number of out of area students who could not be placed in area.
- Approved renewal of VICC's insurance coverage through the MUSIC program effective January 1, 2026 for property, liability and workers' compensation during the 2026 calendar year at a premium not to exceed \$12,500.
- Approved the annual audit of VICC's 2024/25 financial statements. While there were no concerns or issues noted in this report, the accounting firm of Fick, Eggemeyer & Williamsons CPAs did note VICC's continued use of the cash basis of accounting during 2024/25. No management issues were noted during the audit and there are no recommendations for improvement.
 - Approved the filing of VICC's IRS Form 990 for the year ending June 30, 2025.
- Reviewed the summary of investments. As of September, 2025, the total for cash investments is \$35,807,901.27.
- Reviewed reports on VICC's financial position. Through September, 2025, revenues totaled \$6,652,635.59. Expenditures for that period were \$2,588,805.74.
 - Received the current enrollment numbers by district and grade. As of September 24, 2025, there were 1,564 city -to-county transfer students and 35 county-to-city transfer students.
 - Discussed the need to amend the bylaws to increase the term served by the Board Chairperson and Secretary to a maximum of two years .
- Received the 2024/25 Student Attendance Report . The overall average student transfer attendance rate increased from 90.67% to 90.75%. GPA and school district have consistently been the two factors with the strongest correlation to attendance rates
 - Received updated copy of VICC history and talking points document.
 - Discussed the list of annual agenda items for 2025/26.
